This product is prepared from fresh chili peppers that are dehydrated, milled to desired particle size, and blended to achieve desired pungency and flavor. No more than 2% silicon dioxide is added as a flow agent. Raw material shall be free from decay, sunburn/sunscald, insect damage, disease, foreign material or any other deleterious damage or materials. The flavor is mild to moderately pungent, typical of paprika. The aroma is mild to moderately pungent, typical of paprika and the appearance is a natural red to reddish orange, free flowing powder.

Scientific Name: Capsicum annuum L.

Treatment: Product is not treated, but may contain components treated with steam or ethylene oxide.
