### I. Product Description

This product is prepared from fresh chili peppers that are dehydrated, milled to desired particle size, blended with spices, and processed to achieve desired pungency, color and flavor. No more than 2% silicon dioxide is added as a flow agent. Ethoxyquin is added to retard color loss.

The flavor and aroma are mild to moderately pungent chili pepper with garlic, earthen, and caramelized notes. Appearance is dark red to light brownish red, free flowing powder.

Treatment: Product is not treated but may contain components treated with ethylene oxide.

Chili Peppers, Spices, Salt, Garlic Powder, Silicon Dioxide, Ethoxyquin <100 ppm
